Biography

The Honourable Kelvin K. Ogilvie, C.M., Ph.D., D.Sc., H.Col., F.C.I.C., Senator, was (1993–2003) President and Vice-Chancellor of Acadia University in Wolfville, Nova Scotia where he led the development and implementation of the acclaimed Acadia Advantage Program which was recognized by, and incorporated into, the Permanent Collection of the Smithsonian Institute in Washington, DC in 1999. He is a leading expert on biotechnology, bioorganic chemistry and genetic engineering. His scientific accomplishments include the development of the "Gene Machine", an automated process for the manufacture of DNA. He is the inventor of Ganciclovir, a drug used worldwide to fight infections that occur when one's immune system is weakened. Both of these achievements were recognized in 2000 as "Milestones of Canadian Chemistry in the 20th Century" by the Canadian Society of Chemistry. He also developed a general method for the chemical synthesis of large RNA molecules, demonstrated by the first total chemical synthesis or a functional Transfer RNA (tRNA) molecule, which is still the basis for RNA synthesis worldwide. He has also written and spoken extensively on the challenges facing Canada as a nation, the role of the "knowledge" economy, postsecondary education and entrepreneurship.

Senator Ogilvie became a faculty member in the Department of Chemistry at the University of Manitoba in 1968. He moved to McGill University in 1974 and in 1984 was appointed founding Director, Office of Biotechnology, and Canadian Pacific Professor of Biotechnology at McGill. In 1987 he moved to Acadia University to serve as Vice-President (Academic) and Professor of Chemistry.

Senator Ogilvie has served on numerous national and international organizations, including the Atomic Energy Control Board, the National Biotechnology Advisory Committee, the National Advisory Board for Science and Technology, and the Canadian eBusiness Initiative. He has served as scientific advisor to numerous technology companies and as a consultant and expert witness for international pharmaceutical and biotechnology companies. He is a widely sought after speaker, has a number of patents, and his 150 scientific publications have received more than 5500 citations. He recently completed a three-year term as the initial Chair of the Premier's Council for Innovation (Nova Scotia), membership on the Board of Genome Canada, was a member of the Expert Panel on Federal Laboratories (Treasury Board), chaired the Scientific Advisory Board of NRC's Institute of Marine Bioscience, and chaired the Advisory Board for the Atlantic Innovation Fund.

Senator Ogilvie was named a Steacie Fellow in 1992, was admitted to the Order of Canada in 1991, and in 1992 received the Manning Principal Award as Canada's outstanding contributor to innovation. He was identified as a Canadian Who Made a Difference in the 1988 Maclean's Honour Roll, has received three honourary degrees, the Queen Elizabeth Golden Jubilee Medal, the Commemorative Medal of the 125th Anniversary of the Confederation of Canada, and appeared as a mystery guest on "Front Page Challenge" (1988). He has also received the Buck-Whitney Medal of the ACS (1983). Senator Ogilvie was named an Honourary Colonel in the Canadian Air Force and was an inaugural inductee into the Nova Scotia Discovery Centre Science and Technology Hall of Fame in 2002. In 2009, Dr. Ogilvie was inducted as one of four inaugural inductees into the Girindus "Wall of Fame" for oligonucleotide synthesis.

Senator Ogilvie was appointed to the Canadian Senate by Prime Minister Stephen Harper on August 27th, 2009. He is currently the Chair of the Senate Standing Committee on Social Affairs, Science and Technology, a member of both the Health Minister's and the Environment Minister's Advisory Caucus Committees and the Chair of Research Canada's Health Research Caucus.

Dr. Ogilvie was inducted into the Canadian Science and Engineering Hall of Fame in Ottawa in November, 2011 and received the Biomedical Science Ambassador Award in May 2012 in Ottawa awarded by Partners in Research.

The Honourable Michael L. MacDonald is a Nova Scotia businessman and long-time Conservative activist. He was appointed to the Senate on January 2, 2009, on the advice of Prime Minister Stephen Harper.

Born on May 4, 1955, in historic Louisburg (now Louisbourg), Cape Breton, he is the youngest of 10 children in a family with ancestral roots to some of Cape Breton's earliest settlers.

Senator MacDonald attended King's College at Dalhousie University in Halifax, graduating in 1977 with an Honours degree in political science. He first came to Ottawa in 1978, working as a researcher in the Progressive Conservative Research Office until 1980. Returning to Nova Scotia, he worked in the office of the Hon. Gerald Sheehy (1980-82), and later served as Executive Assistant to Premier John Buchanan (1982-84). Thereafter, returning to Parliament Hill, he served as Executive Assistant to the Hon. Tom McMillan (1984-85), and later to the Hon. Stewart McInnes (1985-87).

Since 1988, he has been the President and owner of the Fortress Inn Louisbourg, a motel and restaurant complex near his family home in Cape Breton.

He ran twice for federal office, first in 1988, in the riding of Cape Breton-East Richmond, and again in 2004, running in Dartmouth-Cole Harbour. He also ran twice provincially for the Nova Scotia Progressive Conservative Party in 1993 and 1998.

Until his appointment to the Upper House, Senator MacDonald served as Vice-President of the Conservative Party of Canada, and the party's National Councillor for Nova Scotia

He currently sits on the Standing Senate Committees on Fisheries and Oceans, as well as Transport and Communications.

In addition to his parliamentary duties, Senator MacDonald serves as Treasurer to the Canada-Korea Inter Parliamentary Friendship Group, as well as Vice-Chair to both the Canada-United States Inter-Parliamentary Group, and the Canadian Section of ParlAmericas. He is also an active member with: the Canada-Europe Parliamentary Association; the Canadian Delegation to the Parliamentary Assembly of the Organization for Security and Cooperation in Europe; the Canada-China Legislative Association; and, the Canada-Japan Inter Parliamentary Group.

He has also maintained an active role in the Nova Scotia community – coaching minor hockey and baseball, raising funds for cystic fibrosis research, as well as supporting various organizations to promote and preserve Nova Scotia heritage and the Gaelic language.

Senator MacDonald currently resides in Dartmouth, Nova Scotia, with his wife Marilyn, and their two sons, Lauchlan and Liam.

Stephen Greene has extensive business experience as well as political and public service experience at federal and provincial levels.

Mr. Greene's first important job was at the Canadian Embassy in Washington DC where he was asked to report on how the United States made its fisheries policy in the aftermath of the 200 mile limit. Subsequently, he managed the government relations of H.B. Nickerson & Sons Limited, the largest offshore trawler company on the East Coast. At the time, Nickerson owned the majority of shares of National Sea Products.

While in the fishing industry, he was asked to return to the Foreign Service. He was sent to the Canadian Consulate in Boston where he managed the new boundary in the Gulf of Maine and played a significant role in defeating a countervailing duty investigation into fresh and frozen groundfish from Canada, which had been launched by the United States, saving Canadians hundreds of millions of dollars.

He subsequently joined Clearwater Fine Foods, Inc where he was Assistant to the President (John Risley) for eight years and helped build the company into the largest and most important seafood company in Canada. At Clearwater under Greene's guidance, the Canadian fishery adopted a system of transferable property rights which enabled investment to thrive.

By the early 1990s, Greene had become worried by Canada's self-defeating deficits and so joined the Reform Party for which he was a candidate in the 1993 and 1997 elections. Mr. Greene also served as Chief of Staff to Preston Manning of the Reform Party of Canada from 1993 to 1996 during which he helped manage the opposition response to the national unity and fiscal issues of the day.

He subsequently worked in the insurance industry and became engaged in national and international insurance issues.

In 2006, he became Principal Secretary and Deputy Chief of Staff to Nova Scotia Premier Rodney MacDonald with wide responsibilities to help the Premier administer an effective government for Nova Scotians. He played a significant role in fixing the Atlantic Accord and bringing value to the Crown Share.

He was appointed to the Senate in December, 2008.

Mr. Greene was born in Montreal and went to high school in Lorne Park, Mississauga, Ontario. He has an Honours BA from McMaster University and an MA from Dalhousie University. He lives in Halifax. His daughter, Lana, is in the McGill University Ph.d Chemistry program.

Senator Cowan was educated at Dalhousie University where he obtained his Arts and Law degrees. He then attended the London School of Economics where he was granted a Master of Laws degree. In 2009, Dalhousie University awarded him the degree Doctor of Laws (honoris causa).
